AWARDS CRITERIA



YOUNG TALENT AWARD

- Employed by a GAMBICA member company
- Aged 35 or below during 2020
- Has performed and achieved beyond expectations at their work



INDUSTRY CONTRIBUTION AWARD

This award is to celebrate those who have not only worked tirelessly for their own company, but have contributed to the wider industry and the GAMBICA community as a whole. Aimed at those who have participated in collaborative efforts such as GAMBICA working groups, Standards committees, Regulatory consultations or other collective activities.

- Employed by a GAMBICA member company
- Has made a significant contribution to collaborative industry initiatives

NOMINATIONS AND DEADLINES

Nominations can be made at any time during the year, but must be received by **Friday 16th October** at the latest.

Nominations can be made by anyone, but must be to nominate a person who is employed by a current GAMBICA member company and meets the criteria for that award.

Nominations should be made using the appropriate form, returned by email to awards@gambica.org.uk

JUDGING PANEL

The nominations will be considered by a judging panel, consisting of representatives from the GAMBICA staff, the GAMBICA Board, GAMBICA member companies and relevant stakeholder organisations. The panel will decide the winners of each category using a scoring system for the award criteria.

All nominees will be invited to attend the GAMBICA Annual Lunch, to be held in London on **26th November 2020**. The winners will be announced during the event and presented with a trophy.
